Notes:

- Members are advised the Constitution of 2011 is the extant document. Any amendments to the Constitution have to be approved by a general meeting on proper notice.
- The meeting will take place in person and online. A quorum of 24 members is needed. One third of the total membership.
- Members whose subscription of £5 (single) or £10 (household) was paid on or before 10th May, 2022, may vote. In the case of household memberships, two people in the household may vote. The Treasurer has a list of the memberships that are paid.
- The Chairman's and Treasurer's reports will also be published no less than 24 hours prior to the meeting.
- The 2011 Constitution requires the election of just 4 officers, as in item 6 of this Agenda. They comprise the Executive Committee and by law must become trustees of the charity. Other members may be co-opted to the Executive Committee to provide assistance. Special trustees are appointed by the Executive Committee where required (they are required only if there is land to be held).
- The current Executive Committee members, Lucy Russell, Geoff Collett, Jon Martin and Chris Henwood are willing to stand for re-election and nominations have been made accordingly.
- If there are more candidates than vacancies, a ballot will be held.
- Nominations for different committee members to be elected, signed by the candidate, the nominator, and the seconder, should be delivered to the Secretary in hard copy form not less than 3 days before the AGM. (A copy of the form is attached to this agenda.)
